The minutes of the previous meeting were confirmed and signed by Madam Chairman.

- (2335) Crime Figures & Anti-Social Behaviour  
 The clerk received the monthly Street Beat Newsletter, there was no mention of Sproatley. Cllr Chamberlain to ask the Police for crime figures for Sproatley.
- (2453) Wyre Footpath  
 A letter was received from the owners of Jomar who were not happy with the Parish Council for not contacting them before work was carried out on the footpath of their land. Cllr Buck had made his best attempts to speak to the residents of Jomar. Cllr Chamberlain to send a letter to the residents with an apology from the Parish Council.
- (2458) Rathlin Energy Liaison Committee.  
 A date for the next Community Meeting has not been arranged. Cllr Chamberlain did speak to Rathlin about grants for the area, Rathlin answered that if they are successful then grants will be looked into.
- (2491) Footpath, Sproatley – Wyton  
 Weed killer has been sprayed along this footpath however it will not help to widen the footpath. Still ongoing.
- (2511) Bus Service  
 A few more surveys were received. A poster from Aldbrough Parish Council was sent to us with details of a bus service with Pearson Coaches, a timetable will follow.
- (2517) Sproatley Playing Fields Grass Cutting  
 Sproatley Football Team have stopped using the Pavilion.
- (2523) Gritting on Burton Constable Road  
 The clerk and Cllr Gunnis to complete the survey. The clerk to contact Ellerby, Burton Constable and Humbleton Parish Council to ask if they can organise the same survey from their areas.
- (2524) Defibrillator Update  
 Still ongoing
- (2525) Telegraph Poles  
 The clerk chased KCOM, still ongoing.
- (2527) Land – Main/Gallands Road  
 Meeting to be organised, still ongoing. Cllr Buck to contact The Syndicate of Horticulture regarding the untidy area where the daffodils have grown.

 The grit spreader was taken to Thompsons for potential repair by Cllr Gunnis. District Cllr Holtby mentioned that there is funding available at Witherwick Wind Farm if we need to purchase a new grit spreader. The clerk to investigate.
