(2458) Rathlin Energy Liaison Committee

At the last Community Liaison Meeting held on 15th January 2019 it was advised that they are in the process of securing a larger drill rig which once available work will start on drilling the rest of the well. This will be a 24/7 continuous operation and will take 6 to 8 weeks to complete, Rathlin have submitted a revised traffic management plan & ERYC Highways Team is currently being consulted, the same route & advised speed limits were still part of the plan but the necessity to display Rathlin Energy signage had been removed. Cllr Cochran and Cllr Urry advised they are receiving updates.

(2511) Bus Service

Cllr Cockbill has sent a letter to Graham Stuart MP regarding the situation, awaiting reply.

(2517) Sproatley Playing Fields

Having used the allowed percentage from the 200 Club sufficient funds are available to install the new equipment in the Spring. The football club are paid up to date for grass cutting. New forms for the bank account have been completed to bring up to date.

(2525) Telegraph Poles

Still ongoing.

(2527) Land – Main/Gallands Road

Cllr Cochran to contact Treasure House to try and locate the original planning application.

(2528) Gritting of footpaths

Cllr Gunnis advised cost to purchase a grit spreader was £250, Cllr Cochran proposed, Cllr Jackson seconded, all in favour.

(2534) Christmas Lights

Cllr Wright suggested putting the lights on the tree earlier in November, securing at the bottom for safety. The tree requires some maintenance for dead branches and to train further growth. Cllr's Jackson, Urry & Gunnis to arrange.

(2535) Trees – Village Hall

Madam Chairman to contact ERYC tree department again.

(2539) Trees Manor Close

It has been brought to Council's attention that ERYC had removed some quite substantial trees on the land forming part of Manor Close, owned by Sutton Developments. There had been one complaint from an individual about the height of the trees who had asked for them to be merely reduced in size. Clerk to contact ERYC to clarify why these had been fully removed and if to be replaced.

(2540) Parking

Cllr Wright had been approached by a resident complaining about vehicles parking from Burton Constable Holiday Park, however, it was discussed if the vehicles are taxed and not parked illegally then no action could be taken.

(2541) Environment Agency

The Environment Agency held a meeting with Cllr's Buck, Jackson & Urry in attendance along with 30 members of the public. They commented that it was a very informative meeting with representatives from the Environment Agency confirming matters regarding Rathlin. They advised they are regularly monitoring the site but only for water spillage and not traffic or other matters arising from the site.
