# (2590) Sproatley Memorial Institute

Madam Chairman advised very little money has been coming in for the hall and the heating now has to be turned on and the insurance will be over £1000 she asked if any help could be provided by the Parish Council.

Cllr Wright proposed £1500 donation as the Hall is for all the people of Sproatley and Madam Chairman and Mrs Mary Sykes should not have to worry about it on their own, Cllr Tomlinson seconded - 9 Councillors in favour

#### (2591) Precept

Clerk provided Income and Expenditure for the current year.

It was discussed to keep the precept the same at £13,500 Cllr Gunnis proposed Cllr Cochran seconded - 10 Councillors in favour

### (2592) Revised Code of Conduct

Clerk had received from ERYC a new code of conduct to be adopted. Clerk to contact ERYC before agreement as not clear what the changes have been.

#### (2593) Stalls on The Green

The Church had asked if they could have some stalls on The Green to raise funds. Cllr Jackson thinks this should be allowed but only 2/3 stalls in dry weather and only 2/3 times a year. Cllr Cockbill stated it should be with conditions that it is only for charitable fundraising.

Cllr Jackson proposed, Cllr Tomlinson seconded - 10 Councillors in favour

# (2594) Road markings Park Road

Terry Weaver from ERYC had contacted the Clerk as he had received a request to refresh the hatching markings at the Park Road junction he was also asking if the Parish Council would be in support of double yellow lines.

Councillors discussed that the parking situation had got worse on the junction and concerns were being raised of emergency vehicles having difficulties.

It was discussed if residents would have problems with parking restrictions but all properties do have drives at the rear.

Cllr Cockbill proposed double yellow lines Cllr Buck Seconded – 7 Councillors in favour

### **Correspondence**

Clerk had received an email from Newbald Parish Council asking if all the Parish Councils would put their name to a letter to ERYC expressing concerns and suggestions of improvements regarding Parish Council comments on planning applications and getting in touch with the ERYC. Cllr's would make a decision on this once the draft letter had been seen.
