(2458) Rathlin Energy Liaison Committee

Clerk had received an email from the Clerk of Burton Parish Council in connection with the recent planning application by Rathlin for an additional 6 wells at the West Newton Site. He suggested a meeting of the 6 local councils to discuss this further. Councillors agreed this would be a good idea, Clerk to contact to be included in this meeting.

### (2584) Churchyard footpath

The 2 seats situated on the roadside are falling apart and are rotten. Madam Chairman advised they were originally installed by a young offenders rehabilitation programme but this was quite some years ago. Clerk to look into any scheme available and obtain quote for 2 new benches.

#### (2587) Sproatley Playing Fields bins & grass cutting

Grass cutting still ongoing for cost and what is to be cut. Clerk advised the Withernwick Grant Fund for  $\pm 1000$  had been received towards the cost of the new bins.

#### (2588) Darren Chamberlain resignation letter

The points raised in the letter were discussed and Cllr Gunnis agreed that the Parish Council needs to be more proactive and hold online meetings if the same lockdown situation occurs again. Clerk advised that the website is kept up to date and her email and telephone numbers are displayed if anybody has any issues they wish to raise.
