#### (2458) Rathlin Energy Liaison Committee

Cllrs Gunnis & Urry attended the ERYC meeting decision at County Hall which had a poor attendance. The representatives including John Holtby mainly gave negatives for the planning but then concluded it should be passed. They both felt the decision meeting was a waste of time and knew the planning would be passed.

Clerk had received and read out a letter from Graham Stuart in response to contacting him regarding his views on Rathlin. He confirmed that Rathlin's planning applications are for conventional drilling for oil and gas and are not for fracking for which there is currently a moratorium in England. His view is that renewable energy is now the cheapest power available and combined with insulation, nuclear and North Sea gas will provide long term energy security. He stated that as a member of parliament he does not have a role in the decision of any planning applications but is on hand if the Parish Council has evidence that the proper planning and consultation processes are not followed.
