Correspondence

Clerk had heard back from Samantha Whyte with the same response that ERYC do not own this land and suggested the homeowners contact the land registry to ascertain who owns the land.

Cllr Constable updated that this is still ongoing and is running alongside the lease being sorted.

Madam Chairman read out a letter from Sproatley PCC advising the Scarecrow Festival would be taking place on Sunday 14th September and asked if The Green could be used again on the day and if the PC would kindly be able to offer a prize donation of £25. Cllr Smales proposed Cllr Styche seconded – all in favour.

Clerk made everyone aware of the recent posts on the SproatleyHub regarding a resident's fence having to be taken down due to not having planning permission. The Clerk advised that the PC had not been consulted on this and first became aware of it from the posts. Cllrs discussed and agreed that the Clerk to put a post on the Facebook page stating our position.
