Clerk had received an update from Kirsty Mills following the meeting the football team had with the FA and East Riding Council regarding grants. The summary being - there is not going to be a new pavilion in the near future but there are possibly smaller grants available via the FA for other projects. East Riding are also going to go back to them with further information, again this is probably going to be for smaller grants.

(2647) Community Maintenance Team

Nothing done recently due to weather and busy time of year.

It was requested if £30 could be spent on some more bulbs to plant around the village. All agreed and in favour.

(2649) Defibrillator relocation

Still waiting for the old box to be decommissioned and the electric disconnected at the shop.

All agreed, happy with the location and don't think any further light needs to be fitted.

A paramedic who lives in the village has said she will be happy to help with the defibrillator. Cllr Smales to contact her.

(2660) The Green

A lady had been recommended to Cllr Smales who offers support and advice on projects and helps to find grants.

Cllr Smales arranged a free initial meeting with her on 17th December for ideas and initial plans, what could be achieved for the community and if it is a good idea or not. If the decision is to take it further, the cost would then be £40 per hour for 10 hours.

In the meantime, we will look to arrange a questionnaire and consultation period for residents' views.

Clerk to make a note to put on the Agenda in October 26 so things can be organised earlier and possibly have a sub-committee for organising the event.

(2668) Lloyds Bank closure Hedon

Clerk contacted Graham Stuart who advised that he would write a letter to all residents.

(2669) ERNLLC

The Clerk had contacted a few nearby Parish Councils and most had at some point subscribed and would recommend.

ERNLLCA offered a subscription until the end of March 2026 for a one off payment of £208. Cllr Gunnis proposed Cllr Jackson seconded – all in favour to subscribe on a trial basis.

(2670) 25-26 Precept

Clerk provided details of how much the precept amount would determine Council Tax bills and gave out an up to date Income & Expenditure so far for the current year. After discussions, Cllr Constable proposed the precept of £14,000, Cllr Greenbank seconded – all in favour. Madam Chairman and Clerk signed form to be emailed to ERYC to confirm.
